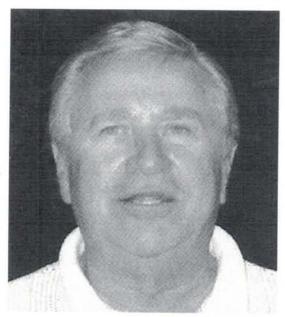

TELLURIDE REGIONAL AIRPORT AUTHORITY BOARD MEETING

May 15, 2019 12:00 pm

1. Call to Order 1:25pm

Chair Jon Dwight called the meeting of the Telluride Regional Airport Authority to order.

Roll Call

Present: Chair Jon Dwight, Vice Chair Larry Crosby, Board Members Gary Bash, Mick Francis. Board Alternate Mark Silversher.

Also present: Kenny Maenpa (Airport Manager), Linda Soucie (Administrative Assistant), Denise Scanlon.

Absent: Board Member Lars Carlson, Lynne Beck, Matt Skinner, Kris Holstrom, Clifford Hanson. Board Alternate Richard Child.

2. Public Comments

Denise Scanlon introduced herself. She has worked at TEX for GLA, and Boutique. She is interested in serving on the Board as an alternate for San Miguel County. She is in touch with Kris Holstrom.

3. A. Approval of Minutes: March 21, 2019

Motion

Mick Francis motioned to approve the March 21, 2019 minutes. Gary Bash seconded the motion. Motion passed 5-0.

B. Chair Report - Dwight

Jon Dwight commented on the very exciting day for the Airport. Denver Air Connection made its inaugural fight into TEX and there was an event with ticket/voucher giveaways, food, champagne, etc. It has been a long process to get the approaches. Jon thanked Alec (Flight Tech Engineering, LLC), Kenny Maenpa, Wade (DAC) and Matt Skinner.

Kenny Maenpa noted that the final details on the lease agreements with DAC and will be ready to be signed by Jon Dwight soon. The TRAA Board granted Jon Dwight permission to sign the lease.

C. Financial Report

1. Ratification of Expenditures (Vendor Payment Report) Mar/April.

Motion

Gary Bash motioned to approve the ratification of the Vendor Payment Report for Mar/April. Larry Crosby seconded the motion.

Motion passed 5-0.

2. Audit Report (In Progress): Lyman Hamblin, CPA – Hamblin and Associates, LLC Lyman Hamblin was introduced and gave an overview of the current audit. He stated that the one correction he had was the process in which amendments to the budget are made. Going forward, anytime an amendment to the budget is to be made, it must be posted or published using the same process as the original annual budget.

There was also a recommendation for the new Airport Accounting Procedures. Lyman's recommendation was to use a Federal guideline compliant procurement policy.

Jon Dwight commented that after the adoption of the Airport Accounting Procedures, the bill.com/check signing procedure could go to the \$25,000 limit with approval of the Airport Manager only, for budgeted expenses.

3. Airport Accounting Procedures

Motion

Mick Francis motioned to adopt the Airport Accounting Procedures, with the amendment to add the Budget Amendment process.

Larry Crosby seconded the motion.

Motion passed 5-0.

E. Colorado Flight Alliance Report

Matt Skinner was absent. The inaugural flight for Denver Air Connection was today.

4. Airport Manager Report

Kenny Maenpa

Updates:

- AIP 35 Airfield Electrical Building Request for bids will go out early June.
- Operations and Maintenance
 - Hangar 29 had damage caused by sliding snow, to the wall, window and gas line. Repairs are underway.
 - Airfield painting is currently in progress.
 - AWOS The system is 100% operational. There will be minor upgrades to the radio and antenna done this summer. This would implement ground radio communications with Denver. Jon Dwight offered to do a test of the AWOS and report back to Kenny.
 - Parking lot rehab will start soon (this is in the budget). There will also be additional paving done in the tie-down area. The lane to Gate 2 will be completely rehabbed and repaved. New bollards with chains in between will replace the Jersey barriers. A new drainage system will be installed at the edge of the pavement at the concrete and the concrete will be repaired as necessary. The new parking plan will add another 20 spaces and possibly move the rental car return lot on the other side of the Gate 2 lane.
 - EMAS blocks The company that manufactures the block is back making blocks.
 - There will be repairs made to the east fence.
 - The terminal carpets have been cleaned, new signage is up for the 2 airlines and new seating has been installed in the terminal area. Eagle sent out a notice that they are giving away their terminal seating, so Kenny has requested 40 seats from them to install in the secure waiting area.
 - The upstairs ceilings have all been painted.
 - Plans and drawings are being made to convert the kitchen into a commercial catering kitchen. The design plans and budget will be presented at the June meeting.
 - Larry Crosby asked about repairing the tear in the terminal east wall. Kenny is working on repairs.
 - Kenny Reported on the staff reorganization he is implementing. Linda Soucie's title has been changed to Business Administration Manager. Jason Currie has been promoted to Operations Manager, and Travis Weber will be the Maintenance Supervisor/Fire Chief. Both Jason and Travis will be shift managers/transportation coordinators (for staff transportation). They will work 4-day, 10-hour shifts, overlapping on Wednesday. They will be working, during season, 1 weekend day each.

PROJECTS

- o AIP 35 Airfield Electrical Building
 - Bid was advertised for Construction and installation of a Bally Modular Building has been advertised. Bid opening is scheduled for June 28, 2019.

OPERATIONS/MAINTENANCE

- · Equipment preventative maintenance, repairs, etc. are on-going.
- Airfield Painting was completed in May.
- Annual FAA Certification Inspection August 5-7th.
- Parking Lot and Apron rehab completed Friday 6/12. Due to extensive damage, the costs for rehab is higher than estimated and will need a budget amendment.

TERMINAL/BUILDINGS

- Eagle County is giving TEX Airline Seating for the passenger holding area.
- Sidewalk drainage has been installed and repaired.
- Design and Planning is underway for a commercial kitchen upgrade for the terminal. Information Memo attached.

Airport Staffing: Hire of one new CSR starting on July 1. Annual Part 139 Fire Training was completed in April. The Airport maintains qualifications for 8 Aircraft Rescue Fire Fighters (ARFF).

RNAV (GPS) M – LPV Special: Flight Validation with FAA was completed on March 1, 2019. The FAA inspector was satisfied with the precision-like approaches and airborne obstacle assessment from the south and north to the Cones VOR and straight to Runway 9. Environmental process is underway. Expect FAA approval by August 2019.

LOC M Procedure (Airline non-precision approach): Submittal has been approved by the FAA. Removed the Category D Aircraft and AQP requirements from the procedure. The procedure is now approved for Category A-C Aircraft.

CARS & COLORS 2019: Aviation Venue September 28th — Requests for aviation support has been submitted to the USAF, USMC, Navy, and Army for aircraft for static displays only. Scheduled two aviation performances. Hangar has been reserved for Car displays and an evening social event.

Commercial Kitchen

OBJECTIVE: Construct and equip a fully functional commercial kitchen in the Airport Terminal.

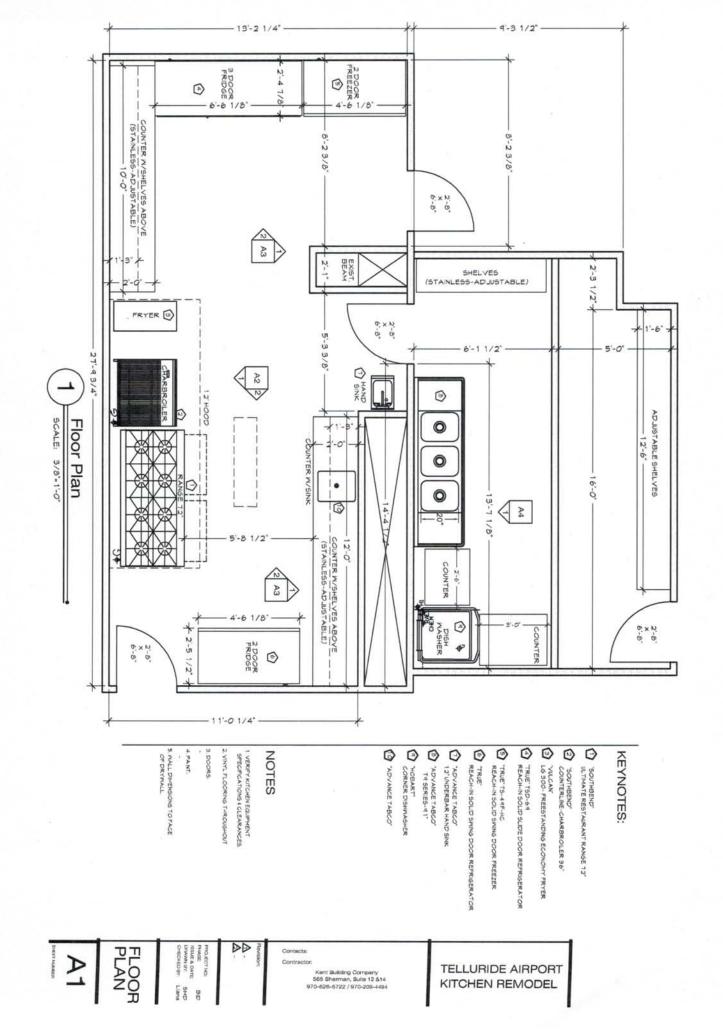
BACKGROUND: TEX currently partners with one catering company that has contracts with NetJets and Air Culinaire to provide food catering for aircraft. The current catering is prepared off-site and has been reliable providing services to aircraft for over the past 10 years. There is opportunity for growth and enhanced airport food catering services prepared on site as well as potential to provided limited food services for passengers (25-30), contractors, residents, and employees (15-25) that are on the airport daily.

BUDGET IMPACTS: A detail cost estimate for equpment, ventilation, and construction concept design is currently in progress for the Board to consider for a budget amendment. Floor Plan is attached. The revenue sources would be a combination of a percentage of catering sales and a monthly lease of the kitchen space.

Estimated annual revenue: \$20,000 to \$30,000

RECOMMENDATION: A detail cost estimate for construction, equipment, and ventilation will be completed and prepared for consideration.
