AIRPORT MANAGER REPORT May 2020

COVID-19 Virus Pandemic - Airport Update

- DAC Air Service: Scheduled to resume flights (3 days a week M,W,F) on June 1st.
- AIRPORT REMAINS OPEN FOR ESSENTIAL TRAVEL ONLY.
- Airport Staffing Skeleton crews cycling 2 employees per day seems to have worked through April. Gradual transition and increase to full staffing during May to complete several off-season projects. Employees are maintaining guidelines and social distancing. Employees are healthy and no positive cases of Covid-19.
- Terminal The commercial airline ticket counter lobby is Closed until June 1st. FBO
 Terminal is sterilized and cleaned daily. Employees are provided with masks and gloves
 for protection. Customer service counter has stanchions to maintain 6 ft. from the
 employees and minimize all contact.
- Airport is operating per the guidelines outlined by the State of Colorado and San Miguel County.
- The <u>Coronavirus Aid</u>, <u>Relief</u>, <u>and Economic Security</u> (<u>CARES</u>) <u>Act</u> (<u>H.R. 748</u>, <u>Public Law 116-136</u>) has been awarded TEX a grant for \$30,000 to cover the costs related to the shut-down. The Airport funds will be utilized in the reimbursement for employee pay and benefits during the shut-down. AIP 36 grant offer was awarded for signatures on May 5th.

Airport Business Strategy through the current economic impacts of the Covid 19 Pandemic:

- Overall national aviation and airlines have been impacted with a 95% decrease in April compared to 2019.
- As the economy emerges out of the national emergency through June, TEX is planning on a reduction of 25% of business revenues through July and August.
- General Aviation will likely rebound quicker than air service through the end of 2020.
- There will not be any additional Capital spending proposed to the TRAA through the end of 2020.
